ICC1 expects the value of counterfeit goods to exceed \$1.7 trillion by 2015. It is over 2% of the world's total current economic output<sup>2</sup>.

#### Quality issues

Imitation goods are tempting as they cost less than genuine products. But, they are of worse quality and may be unreliable or dangerous. In addition, these counterfeit goods do not include after sales service or warranties.

#### Material and Reputation loss

Governments lose on unpaid tax and incur large costs in enforcing intellectual property rights. However it's the brand owners who experience the greatest loss (direct loss of sales, loss of goodwill, irreparable damage to corporate brand/reputation, costs of protecting and enforcing their intellectual property rights, loss of costumer trust).

#### Health

Counterfeit or mislabelled products that have hard fatal consequences include: Toxic cough syrup, tainted baby formula and fake teething powder have all led to the death of children over the past few years.3

Every 45 seconds a child dies of malaria, a curable disease with the proper drugs. Unfortunately 1/3 of all malaria drugs sold in Africa are fake. (Pills contain chalk or washing powder)4



### The Core Technology

A SMark Security Label consists of Nanotech Foil and Protected Data. Together, these two components authenticate a product.


The basis of our technology is the aforementioned Nanotech Foil, which guarantees security through it's micrometer scale and manufacturing technology. It is impossible to reproduce any foil even with the same equipment. Our foil contains several thousand random holes in a square mm.



### Powerful Cryptography

The other pillar of our guaranteed security is the manufacturer's electronic signature. SMark uses the globally trusted public key infrastructure by uniquely generated Protected Data matching each foil (in QR format). Therefore, each product carries a totally unique SMark label.

SMark has developed a user-friendly check interface.


Product verification can be achieved on multiple devices:
